

TECMA TOILET 2-YEAR LIMITED WARRANTY POLICY

Thetford Corporation warrants to the original purchaser of Tecma toilets that are used for personal, family or household purposes to be free from defects in material and workmanship for a period of two (2) years from the date of purchase. Thetford Corporation warrants to the original purchaser permanent toilets placed in commercial or business use to be free of defects in material and workmanship for a period of ninety (90) days from the date of purchase.

LIMITATIONS OF WARRANTY

- This warranty does not apply to products which have been subjected to misuse, negligence, accident, fire, improper repair, improper installation or any other unreasonable use.
- This warranty will be void if the identification number or date of manufacture stamp has been effaced, altered, or removed, or if the product has been repaired or altered by persons other than Thetford Corporation.
- In order to obtain the remedy of repair and replacement, the permanent toilet must be transported to a Thetford Service Center for warranty service. All labor and transportation costs or charges are the responsibility of the purchaser.

LIMITATION OF REMEDY

1. THE RESPONSIBILITY OF THETFORD CORPORATION UN-DER THIS WARRANTY IS LIMITED TO THE REPAIR OR RE- PLACEMENT (AT THETFORD'S OPTION) OF THE DEFECTIVE COMPONENT PART(S).

- IN NO EVENT SHALL THETFORD CORPORATION BE RE-SPONSIBLE FOR: CONSEQUENTIAL OR INCIDENTAL DAM-AGES; DAMAGES ARISING FROM IMPROPER INSTALLA-TION, IMPROPER USE, ABUSE, ALTERATION OR FAILURE TO FOLLOW THE USAGE OR WINTERIZATION INSTRUCTIONS CONTAINED IN THE OWNER'S MANUAL; OR DAMAGES RE-SULTING FROM SPILLS OF HOLDING TANK DEODORANTS OR ADDITIVES OR FROM FLOODING OF TOILETS.
- SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITA-TION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU.
